The **UNA Rx card** is a **FREE** health savings card available to all citizens at **NO COST**. The card is part of a program that offers discounts on **prescription medications**.

- ✓ The program may be used to provide savings on prescriptions not covered by your health insurance or Medicare Part D. The program may also be used instead of your insurance coverage when it offers greater savings than your copay.
